

## **Children's Advocacy Center of Hampshire County (CAC)**

Our mission is to prevent and end child abuse in our community by providing safety, healing, and justice. The Children's Advocacy Center of Hampshire County is an independent 501c3 organization that partners with a multidisciplinary team to coordinate trauma-informed care for child survivors of abuse.

### **Director of Therapeutic Services:**

The CAC of Hampshire County is looking for a licensed clinician, to join our team in responding to child abuse. The Director of Therapeutic Services will be a lead partner in developing a comprehensive evidence-based, trauma-informed mental health program based at the Children's Advocacy Center. The director will help develop our program and provide individual, family, and group treatment to children and teens who have been victims of physical and/or sexual abuse and to their non-offending caregivers at our Northampton site.

### **Specific responsibilities:**

- Provide short-term individual and group, evidence-based, mental health treatment to child victims of abuse and their non-offending family members
- Assist in mental health program development and evaluation
- Complete clinical assessment reports with specific treatment/safety recommendations
- Create and follow comprehensive treatment plans for child clients
- Consult with the MDT (Multi-Disciplinary Team) on cases as needed
- Assist in providing outreach to schools and community about the elements of child abuse and the role the CAC plays in helping children who have been victimized
- Collaborate with and support other CAC team members and outside partners
- Other duties as assigned

### **Qualifications:**

- Independent licensure in social work, psychology, or counseling in MA is required.
- Experience working with children required, 3 years experience in the field of childhood trauma preferred.
- A minimum of 5 years experience in mental health
- Experience with clinical assessments required.
- Must have clinical experience with children, adolescents, and families and familiarity with trauma-informed models of treatment in an outpatient setting.

An ideal candidate will be positive, enthusiastic, patient, flexible, and creative. The candidate must enjoy working collaboratively within a team-based culture. Must have clinical experience with children, adolescents, and families and familiarity with trauma-informed models of treatment in an outpatient setting. Must have experience working with culturally diverse populations and have excellent communication skills. Organizational skills and basic computer fluency are required. Must maintain licensure and all training appropriate to the field. Bilingual and candidates of diverse backgrounds are encouraged to apply. Employment is contingent upon an appropriate background check.
